# 1. Welcome

Heather Cuthbert, Interim chair, was delighted to welcome everyone to the first Annual General Meeting of the recently restructured South West Scotland Regional Network, and extended a very warm welcome to Andrew Watson from the Scottish Housing Regulator (SHR) who was the guest speaker.

# 2. Chair's report – Heather Cuthbert

Heather reminded everyone about the background to the Regional Networks and gave an insight into what drove the need to restructure and its purpose to make the networks work more efficiently and effectively in that all network committee members contribute in a way that uses their knowledge, experience, skills and abilities.

Heather highlighted some of the more notable achievement the Regional Networks had made:

- The Networks have made significant contributions to shaping the Housing (Scotland) 2010 and 2014 Acts and helped develop the first ever Scottish Social Housing Charter
- They gave written and oral evidence to the Infrastructure and Capital Investment committee, during the consultation on the Housing (Scotland) Act 2010, resulting in the Act being amended to require landlords to involve their tenants in preparing their Annual Return of the Charter (ARC) for the SHR and ensuring that Council tenants were protected by the regulatory regime.
- Following concerns by the networks about inappropriate use of Local Authority Housing Revenue Accounts (HRA), we produced an evidence paper outlining the issues and the Scottish Government reviewed and produced robust guidance on what HRA resources should be used for.

Heather ended her report by stating that all of the Network achievements are having a lasting impact, improving services on the ground for all the 610,000 social housing tenants and the customers of social property owners in Scotland. She was confident that the new Regional Network structure would build on these achievements and continue to work effectively with the Scottish Government in areas of National housing policy.

# 3. Andrew Watson, Board member, Scottish Housing Regulator (SHR)

Andrew Watson gave an overview on the future of social housing regulation in Scotland, he advised that there was a planned review of the current framework which was launched over five years ago looking at the future of social housing regulation in Scotland:+

- We published a discussion paper in January 2018 and held a series of events and had written submissions from over ninety individuals and organisations, including tenant organisations and the Regional Network committees.
- The statutory objective hasn't changed, safeguarding and promoting the interests of tenants, people who are homeless and other service users will remain centre stage. The SHR are committed to empower tenants by providing useful, accessible information about landlord performance and promoting a strong tenant voice will also stay core to our work.

- The creation of an Annual Assurance Statement will ensure that each landlord would confirm that it meets the Regulatory Standards and requirements, or set out what it is doing to address any instances of non-compliance. This would be approved by each Registered Social Landlords (RSLs) board or appropriate committee of the local authority. The SHR would use the statements in the risk assessments of all landlords.
- The SHR will be speaking to tenants, landlords and others as they develop this. The role for tenants in the annual assurance is how they capture and use the tenants views of their landlords.
- There is overwhelming support for internal audit to be mandatory for all Registered Social Landlords (RSLs). Most landlords already have internal audit, those that don't are very much in the minority and it will be important that landlords ensure that the internal audit is effective and adds value.
- The SHR will be making the regulatory view of each landlord readily available to tenants, service uses, and others with an interest in social landlords. It is likely that the SHR will focus this around our judgement on each landlord's compliance with Regulatory Standards and regulatory requirements. We will develop our thinking on how we do that, and we'll keep talking over the summer to help us develop an approach.
- The SHR are looking for tenants views on how we can present the view of each landlord in a way that is useful for tenants. Many stakeholders stressed the importance of the SHR continuing to promote a strong tenant voice and to support tenants with accessible and useful information about their landlord. In addition, tenants have told the SHR that information on rent affordability and landlord costs is increasingly important to them.
- The SHR will be taking forward a project over the coming year to see how innovative technologies can help us achieve that objective.
- The SHR will be talking to landlords about the data we collect on their performance against the Scottish Social Housing Charter, to make sure the indicators are as meaningful as possible.
- The SHR will be engaging with many tenants as possible of the autumn with TPAS and TIS supporting them with the consultation process and thanked the Scottish Government for funding this.
- The proposed framework for formal consultation will take place in the autumn and this is all about setting the direction of regulation in the next five years that is effective and sustainable.

In response to this, those present raised their concerns with Andrew that some Local Authority landlords were not engaging with their tenants or taking note of their opinions. They acknowledged that where landlords engage effectively, tenants are generally satisfied with

the services they receive, however where tenants are not being consulted, tenants felt isolated and frustrated with the mechanisms available to instigate chance.

They highlighted the extensive length of time that SPF's take to resolve and not always to the satisfaction of the tenants. They said that the SHR dealt more effectively with housing association landlords but not with local authority landlords. They urged the regulator to look at this matter as tenants felt that there had to be changes made to give them support.

In addition, there were still barriers to resolving the continued misuse of HRA resources which was made more complex by the Audit Commission having responsibility for Local Authority Finances. It was suggested that the HRA could be separated out with the SHR being responsible to monitor its use.

Andrew said that he would discuss their concerns with his colleagues.

#### 4. Regional Networks – Looking forward – Ann Marie Stanley Scottish Government

Ann Marie Stanley, Tenant Participation Development Manager, gave a short presentation about the Regional Networks and moving forward in the future. She highlighted that:

#### The Networks are important as they:

- Provide a broadly representative view of tenant/residents interests in the development of national housing policy
- Give tenants and residents a recognised place alongside the professional sector in working in partnership with the Scottish Government on national policy
- Scottish Government greatly values the networks views and insight in national policy development
- Help shape housing policy in Scotland

#### Achievements:

- · Ensured tenants views are reflected in housing policy and legislation
- Give evidence directly to Parliamentary committees
- · Recognised role, alongside the professional sector, in national policy development
- Input and views highly valued by staff and Ministers
- Influenced and changed legislation and policy

Ann Marie quoted from a committee member that effectively summed up the real impact that the regional networks were having nationally:

"Who would have thought 20 years ago that tenants of social housing would have access to Ministers as we do now. Tenant Participation is working well in Scotland and having the Charter enables tenants to be meaningfully involved in developing national policy and work with our landlords to improve services and standards."

# • Treasurer's report
